Important Questions	Answers	Why This Matters:
What is the overall <u>deductible</u> ?	\$4,000 individual/\$8,000 family <u>network</u> . \$8,000 individual/\$16,000 family out-of- <u>network</u> .	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .  The Medical Expense Reimbursement Program (MERP) administered by Webber Advisors will reimburse for in-network deductible expenses. No out of network deductible will be reimbursed. There is a general deductible where the employee is responsible to pay the first \$1,500 for individual and \$3,000 for family. Participants will be reimbursed 90% of any in network deductible after they have satisfied the above requirements. Participants must submit all explanation of benefits for reimbursement. Are there services covered before you meet your <u>deductible</u> ?	Yes. Office visits, <u>preventive care</u> services, <u>emergency room care</u> , <u>urgent care</u> , outpatient mental health, outpatient substance abuse, <u>rehabilitation services</u> , and <u>prescription drug</u> benefits are covered before you meet your <u>network deductible</u> .  <u>Copayments</u> and <u>coinsurance</u> amounts don't count toward the <u>network deductible</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. For example, this <u>plan</u> covers certain <u>preventive services</u> without <u>cost-sharing</u> and before you meet your <u>deductible</u> . ## Does this plan provide Minimum Essential Coverage? Yes
